

Kyoto Institute of Technology's Regulations
on the Acceptance of International Visiting Scholars

June 12, 2003

Issued by the President of KIT

Revised on June 25, 2015

(Scope)

1. The following regulations govern the acceptance of scholars from overseas (excluding those stipulated otherwise in relevant regulations, and the Staff Work Rules of National University Corporation Kyoto Institute of Technology (established on April 1, 2004); hereinafter referred to as "International Visiting Scholars"), who conduct research at Kyoto Institute of Technology (hereinafter referred to as "KIT") with the aim of promoting international academic exchange at KIT.

(Eligibility)

2. To be approved, a prospective International Visiting Scholar must be a citizen of a foreign country or a Japanese national who is a permanent or long-term resident of another country and meet one of the following requirements:
 - (1) Be subsidized through a Japan Society for the Promotion of Science (JSPS) program
 - (2) Be subsidized through a Japan Foundation program
 - (3) Be awarded a Follow-up Research Fellowship from the Japan Student Services Organization (JASSO)
 - (4) Be subsidized through a program of a foreign government, international organization, or other public organization
 - (5) Be visiting KIT based on one of KIT's International Exchange Agreements
 - (6) Be otherwise approved by the KIT President to promote KIT international academic exchange

(Acceptance)

3. The decision regarding the acceptance of the International Visiting Scholar is made by the President of KIT, based on the opinion of the Director of the International Center, upon a proposal made by a KIT's trustee or academic staff member, who will be responsible for said International Visiting Scholar.

(Duration)

4.
 - 1) Each International Visiting Scholar is accepted for a period of up to 1 year.
 - 2) The duration stated in the preceding clause can be extended only if the necessity to continue research at KIT is approved.

3) Procedures in Article 3 are applicable to extensions of duration.

(Access to facilities)

5. Each International Visiting Scholar has access to KIT facilities upon receipt of permission from heads of relevant facilities.

(Cancellation of acceptance)

6. The KIT President has the authority to void the decision of acceptance of an International Visiting Scholar, in the event the International Visiting Scholar is discovered to have acted in a manner that violates these regulations.

(Other)

7. The KIT President reserves the right to further define the above terms with regard to the acceptance of International Visiting Scholars.

Supplementary Provisions

1. These regulations shall come into effect on June 12, 2003.

2. The KIT Invited Foreign Scholars Acceptance Regulations prescribed by the KIT President on November 25, 1982, shall be abolished.

Supplementary Provision

These regulations shall come into effect on March 14, 2008.

Supplementary Provision

These regulations shall come into effect on January 8, 2009.

Supplementary Provision

These regulations shall come into effect on May 14, 2012.
